edications used to prevent heartworm infect are called preventives. Preventives kill the heartworm larvae before they have a chance to grd mature into adult heartworms. A number of heart preventives are available to pet owners today. Son heartworm preventives contain additional ingredie that will control other parasites, such as roundworr hookworms. A monthly preventive should be given to all pets. Remember that mosquitoes can get indoors, so even

though your pet may not go outside, he is still susceptible.

Internet sites that sell pet drugs can be reputable pharmacies. However, others are fronts for businesses breaking Federal, State and sometimes International law. Illegal online pharmacies may sell medicines that are counterfeit, outdated, mislabeled, incorrectly formulated, or improperly made or stored. You are always welcome to call our office to discuss any questions you may have with veterinary online pharmacies.

Why Our Hospital Pharmacy Is Your Best Choice –

Internet Pharmacies are not always the cheapest source for medication. Our price for most items is typically less than most Internet Pharmacies would charge. In addition, some medications are temperature sensitive and require next day or 2nd day air delivery, which adds to the cost. Prescriptions sometimes need a signature on delivery, so you need be home to receive the shipment.

Our veterinary practice also passes on manufacturers' promotions and/or rebates and these frequently result in greater savings.

These rebates are not usually available from online stores or catalogs.

Using an Internet pharmacy means a delay in getting your medication. It typically takes 1-2 days for the online pharmacy to contact us and process the prescription, then there's a 2-5 day shipping time.

Any prescription medication purchased from our hospital has been inspected and approved by the FDA, and manufactured and packaged according to U.S. government regulations. Medications available online may have been purchased outside the United States and have different strengths and labeling than U.S. products. Sometimes you can tell by checking the label. If approved by the FDA, it should say, "Caution: Federal law restricts this drug to be used by or oh the order of a licensed veterinarian". Do not use products that do not have this warning or if the label has been removed.

or product guarantees when the medications are prescribed by and purchased from the pet's veterinarian. Internet and mailorder catalogs, do not qualify for these guarantees.

Pet Insurance companies require that all prescriptions be FDA approved. If you have pet health insurance you may be reimbursed on medications when purchased from a legal online pharmacy. You will be required to provide a copy of your veterinarian's prescription order and a copy of the Internet pharmacy's invoice. When you purchase a prescription from our hospital there is no additional paperwork. Your hospital office call along with any prescription is all itemized on one invoice for easy submission to your insurance company.

Every week representatives from companies like Bayer, Pfizer, Novartis, Merial, and others visit our office. These representatives have access to the latest data and research, and are a valuable source of up-to-the-minute information. In addition, our staff regularly attends veterinary conferences and reads the latest veterinary medical journals and research papers. We stay up-to-date on the latest disease trends in our region and stay abreast of recent advances in veterinary medicine. However, our first source of information about products and treatment protocols are the pharmaceutical representatives. Heartworm Disease Is A Serious Health Concern

Heartworm infection in animals is a serious health threat that can ultimately result in heart failure and death. One bite from a mosquito can transmit heartworms to your pet. Dogs are the most common victims, but cats, ferrets and other animals are susceptible. Treatment is available for dogs, although it is expensive and may cause complications. Currently, there is no effective heartworm disease treatment for cats. But the affliction can be prevented.

It takes several months for the larvae to mature and move into the heart and other organs.

What are the symptoms of heartworm infection?

Unfortunately, symptoms are not seen during the early stages of the disease and it can take up to a year for any signs of infection. Once the disease is advanced, the pet displays chronic coughing, weight loss and decreased appetite. Pets will lack energy, tire easily and

may collapse from heart failure after playing or exercising. A blood test is available to determine if you pet is infected.

Preventive treatment for heartworm disease, before it advances to the point of seriously jeopardizing your pet's health, is simple and usually 100% effective. Following a blood test to determine if your pet is infected, a once-a-month medication may be administered that destroys any immature heartworms that exist in your pet's bloodstream.

Life Cycle of the Heartworm

Larvae develop into adult heartworms and live in the heart and adjacent vessels

Mosquito bites dog or cat and injects microfilariae

Over a period of a few weeks the micofilariae develop into larvae

Heartworms are slender white worms that can grow to as much as 14 inches in length. They obstruct blood vessels, restrict heart valve function, and can also cause extensive damage to the lungs, liver and kidneys. Mosquitoes transmit the microscopic larvae of heartworms between animals through the exchange of blood.

The environment you live in and the existence of mosquitoes can be a critical factor in your pet's exposure to heartworm disease. That's why it's important to consult with your veterinarian about your pet's susceptibility to this potentially fatal disease.
